- b. Evangelical Social Action Forum (**ESAF**): We signed MOU with ESAF as **SUB-AGRIGATOR** for National Pension System (**NPS**) of **PFRDA** to enrol people for pension under **SWALAMBAN**.

 **NGO Up-Gradation:** - Hindustan Latex Family Planning Promotion Trust (**HLFPPT**) selected SMILE SESVS for NGO Up-gradation Process. Objectives of this up-gradation are as follows:

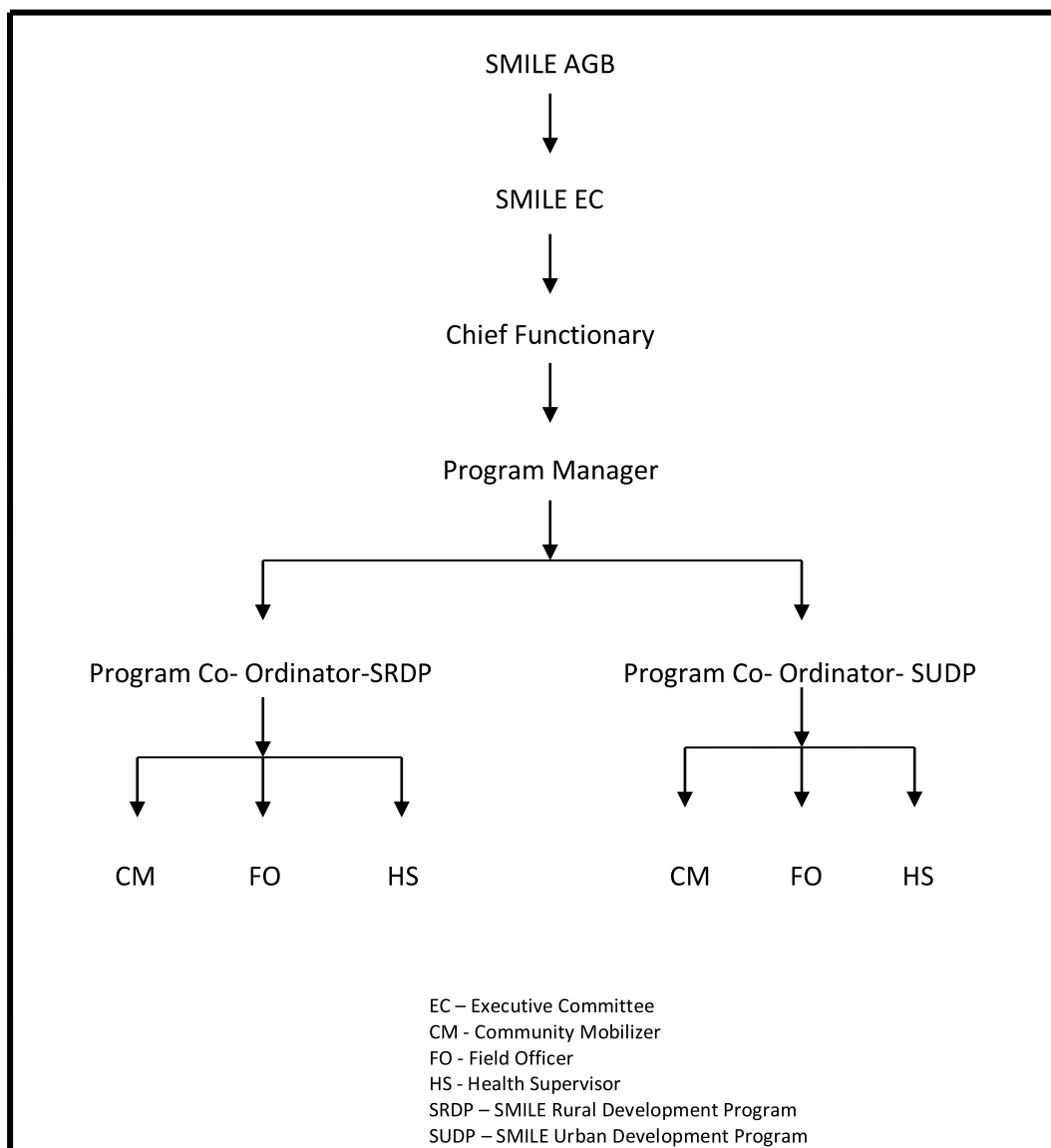
- a. Build up proper NGO perspective.

A. Continuously All Through The Year: -

Community Meetings: -

92 Community Meetings for T.B. sensitization under Project AXSHYA were done in different villages of Bagbahara Block, Mahasamund District. Community Meetings were done with VHSCs, SHGs, Panchayats, other groups, anganwadi teachers along with mitanins. Small groups are sensitized with the objective to enable them to carry on the message and programs targeting ZERO T. B.

Members present in Community Meetings assured to carry the information on T.B. and disseminate at their level. They will also motivate the suspects to get themselves checked at nearest DMC and will help them do so.

Total **16347 people** were covered under AXSHYA Samvad from July 2013 till March 2014.

✚ Mid Media Activities: -

9 Cultural Program were done in different villages in which “Hamar Gaon Ke Sandesh”, a cultural group was briefed on T. B. Awareness and was asked to present the message through skit, Dayaram Sahu, leader of cultural group prepared the presentation in such a way that not only people watched the program but also reflected on health issues and stigmas related to Tuberculosis.



✚ SMILE Child Development Centres: -

With the objective to bring Child Labours and School Drop-Outs into the main stream of education 4 SMILE Child Development Centres catering 145 Child Labours along with other children was continued from last year. Through Non Formal Education, Health & Hygiene along with Games and Recreational Activities all the children were given an opportunity to come & have Holistic Development, but due to displacement of basties (Slums) we had to shut down our 2 SCDCs at Chandinagar and Kabeer Nagar. We still have 2 SCDCs, one at BSUP Saddu and another at Lalpur, Bagbahara.



Sputum Collection, Transportation & Referrals: -

Through AXSHYA Samvad and from out of AXSHYA Samvad total 172 symptomatic were identified, referred 85 and Sputum Collection & Transported of 68 symptomatic out of which 6 were found positive and they were put on DOTS. T.B. Forum: -

Mahasamund T.B. Forum was formed and Mr. Jeetendra Singh is appointed as secretary of District T.B. Forum-Mahasamund. The role and responsibility of T.B. Forum is to ensure adequate treatment and facilities to all T.B. patients and create a friendly environment for T.B. patients challenging all stigmas attached to it. 4 Meetings were organized during the year with the objective to formulate programs and to get T.B. Forum registered.



Organisation Strengthening Programme by HLPPT: -

The Hindustan Latex Family Planning Promotion Trust (HLPPT) conducted Organisation Strengthening Programme in Chhattisgarh with the objective to enhance the capacities of selected NGOs to undertake and implement various development projects in the state. The programme had class room sessions for the lead functionaries of the selected NGOs, handholding support to implement the proposed organisation strengthening activities, online guidance and assessment of capacities was provided. Experienced development professionals with expertise in different sectors of social development lead the proposed programme. Mr. Jeetendra Singh, Chief Functionary and Mr. Rajesh Kripal, Program Co-Ordinator represented SMILE SESVS which was one of the 18 organizations who went through the following sessions during 9 months.

- a. NGO Governance & Program Management.
- b. Fund Management.
- c. Human Resource Management.
- d. HIV & Targeted Intervention.

Mr. Saju V. Joseph, Mr. Vinay, Mr. Prakash Varghees, Mr. Nitin, Mr. Ved Prakash Shukla & Mr. A.V. Gautam from HLPPT were resource persons for aforesaid trainings.



B. Activities Month wise: -

April 2013: -

- a. **NABARD Field Visit** to Villages of Bagbahara, District- Mahasamund on 8th April 2013 NABARD by District Manager, Mrs. Leena Brahma Mohurle, she visited our SHGs at Saraipali, Darbekera Junwani and Ukhra villages of Bagbahara Block. She talked to SHG members and saw their documents like attendance register, meeting minutes register, finance/transaction registers and passbooks.



SGH members shared about the contribution SMILE SESVS has made in their lives. Mohurle mam encouraged all the members to meet regularly, work hard and follow the rules for betterment.

- b. **Training of Trainer** was organized by Reach India for NABARD for selected NGOs for SHPI from 21st & 22nd April 2013 at Hotel B.N. Palace, Raipur. Ms. Sheetal Joshi and Mr. Stephen Sona were the trainer from REACH India. Sessions on SHG formation, Bank Linkage, credit linkage, quality SHG were organized and group discussions were done to formulate strategies for formation and sustenance of SHGs.



All the organizations present participated in the training. Mr. J.S. Lal and Mr. Jeetendra Singh represented SMILE SESVS. Officers from NABARD were present time to time for encouraging all the participants.



All the representatives were awarded with certificate of completion.

- c. **Interview** was organized on 28th April 2013 at Agrasen Bhawan, Bagbahara for Program Co-Ordinator, Health Supervisor and Field Staff.



May 2013: -

- a. **Social Development Training** of SHGs at Paterapali village of Bagbahara block was organized for 175 SHG Members. Under this Social Development Training participatory sessions on Panchayati Raj, Role and Responsibility of SHGs for Social Justice were taken by Mr. Mahesh Sachdev and Ms. Rajani Kashyap. After the presentations SHG members participated in discussions and formulated programs for SHGs to play vital role for Social Justice. One person from each SHG was made responsible to carry on the program and keep the record of each activity.



🚩 **June 2013: -**

- a. **Survey Orientation** at BSUP Saddu, Survey of BSUP Saddu was done on 9th June 2013. Mr. Yohan Masih was given training on survey by Mr. Jeetendra Singh in which information required and form filling was taught.



- b. **Business Development Training** was organized on 27th June for SHG members at Saraipali for Washing Powder Making. Mr. Jeetendra Singh took session in 3 phases which is as follows: -

🚩 July 2013: -

- a. **SMILE School Health Support Program** started as an introductory session at Government School, Jodhapur, Dhamtari. On receiving an invitation from Mr. M. M. Das, Head Master, Government School, Jodhapur Mrs. Prabha Singh, President SMILE SESVS and Mr. Jeetendra Singh, Chief Functionary took an introduction session of all staff of Government School, Jodhapur regarding SMILE School Health Support Program on 31st July 2013. Mr. M.M. Das was very much eager to start SSHSP.



🚩 August 2013: -

- a. **Staff Orientation by Project AXSHYA** was organized by Mr. Sanjeeb K. Barik, District Co-Ordinator on 1st August 2013 at Mahasamund. Sessions on activities of Project AXSHYA and role and responsibility of field staff was shared by Mr. Sanjeeb K. Barik, staff working in SHSP were oriented.



- b. **SHG Program Planning** at BSUP Saddu was done on 17th August 2013 with the members of SMILE Priya SHG. Aim and Objective of SEDP was shared by Mr. Jeetendra Singh, SHG members participated in discussion for planning activities they shared the need of financial sustainability and Health Issues. Objective of this meeting was Training on IGPs like Washing Powder, Mixture Making, Murra Laddu Making and Phynile Making. Mr. Jeetendra Singh assured of some more IGPs .



✚ September 2013: -

- a. **IGP on Washing Powder Making** was organized on 11th September 2013 at BSUP Saddu for members of SMILE Priya SHG. State Livelihood Department of Raipur Nagar Nigam supported this training; Dr. Mrs. Sangeeta Thakur, State Livelihood Specialist & Mr. Dewangan, Engineer from Raipur Nagar Nigam were also present. Trainer, Mr. Rambahadur Vishvakarma was welcomed by Mrs. Nibha Singh, Program Manager, SMILE SESVS. Mr. Rambahadur Vishvakarma shared about raw materials and procedure of making washing powder. Mr. Rambahadur Vishvakarma made SHG members follow the procedure. According to the instructions they mixed raw material and made washing powder.

Mr. Rambahadur Vishvakarma gave them important tips to maintain the quality. 25 women including SHG members were trained.



- b. **Business Development Training (IGP)** was organized on 16th September 2013 at BSUP Saddu for members of SMILE Priya SHG. Mrs. Nibha Singh, Program Manager, SMILE SESVS led this training.

- c. **TOT – Patient’s Charter Training** was done at Mahasamund by Project AXSHYA on 22nd September 2013. Mr. Sanjeeb K. Barik, District Co-Ordinator, Project AXSHYA led this training for Project AXSHYA partner NGOs. All NGO representatives along with T.B. Forum members were given the responsibilities to present Rights & Responsibilities of TB Patient.



October 2013: -

- a. Anti Fire-Cracker Movement** with Child Labors was done on 6th October 2013 at Mahasamund. The objective was to sensitize people about the exploitation of Child Labor in Fire Work Industries and the situation in which they work. An appeal was published to shun the use of Fire Cracker and support this movement. 175 working children participated in this program.



- b. National Consultation on HIV/ AIDS** was organized by NCCI at Bangalore from 9th to 11th October 2013. Representatives from all over India were present. Mr. Jeetendra Singh represented MCI in this consultation. The objective of this consultation was to encourage institutions and organizations to formulate organizational policies for People Living with HIV (HIV friendly Institutions). Fr. Philip Kuruvilla from ESHA-NCCI led this consultation. Sessions concerning HIV/AIDS were taken. All representative shared the activities they are involved in and future plan to address the issues of PLHIV.



c. **Business Development Training (IGP)** was organized on 21st October 2013 at BSUP Saddu for members of SMILE Priya SHG. Mrs. Nibha Singh, Program Manager, SMILE SESVS led this training. This training was organized on the request of SHG members as they conformed the product and wanted to start commercial production of washing powder. The name conformed as “SURYA WASHING POWDER.”

Mr. Jeetendra Singh took session on 3rd phases of BDT Manual of SMILE SESVS which is as follows: -

Third Phase: -

- Quality Control
- Packing
- Marketing

First Sample lot of “SURYA WASHING POWDER” was made with the objective to utilize for themselves and sample distribution.



🚩 **November 2013: -**

- a. Commercial Production of SURYA Washing Powder** started on 8th November 2013 at BSUP Saddu by SMILE Priya SHG. Machinery and equipment was provided by SMILE SESVS to the SHG, this first commercial lot was made and packed under supervision of Mrs. Nibha Singh, Program Manager, SMILE SESVS. Mrs. Eba was trained in reporting and book keeping. 450 packs of ½ kg were packed and set out for sale by SHG members.



- b. SMILE Child Development Centre** at BSUP Saddu was visited by Mrs. Nibha Singh, Program Manager, SMILE SESVS on 9th November 2013. She checked documents, registers and interacted with Child Labours along with other children who come to SCDC for Non Formal Education with Health & Hygiene Activities. Mrs. Ranjana Ganveer is in-charge of this SCDC in which 53 children are registered. SMILE Child Development Centre was started in September 2013 at BSUP Saddu.

Raipur Nagar Nigam has provided flats at BSUP Saddu to conduct our activities. Children come to centre in the evening for 2hrs per day, they are taught through the course developed by SMILE SESVS and study material provided by Pathya Pustak Nigam, Raipur.

Health teachings are also provided.



- c. **Matdata Jagrukta Abhiyan** was done by SMILE Samajik Evam Sanskritik Vikas Sanstha on 15th and 16th November 2013. Members of **SMILE Priya SHG** of BSUP Saddu went door to door and encouraged all the 750 households to participate in voting and be a responsible citizen. Posters were stuck by SHG.



Mrs. Nibha Singh, Program Manager, SMILE Samajik Evam Sanskritik Vikas Sanstha addressed people of BSUP Saddu while carrying out Matdata Jagrukta Abhiyan. Posters were also put at the prominent places like Ghari Chawk, Pachpadi Naka, Bus Stand and Railway Station. Dr. Sangeeta Thakur, head - State Livelihood Department, Raipur Nagar Nigam supported Matdata Jagrukta Abhiyan.



- d. **Staff Orientation** was done on 18th November 2013 at Bagbahara. 15 staffs of SMILE SESVS were re-oriented about all the programs & activities of SMILE SESVS by Mr. Jeetendra Singh. Information on NPS was also shared along with Annual Beneficiary Membership provision made by SMILE SESVS. Mr. Abhilash Philip, Area Manager, Yuva Parivartan was also invited to share about Camps which are done in 25 different trades for financial sustainability. Provision regarding Salary, Honorarium and Incentive was shared with all staff and new staffs were given offer letters.



e. **People's Forum** was organized by NCCI-URM at MCCSS, Chennai 27th & 28th November 2013. Theme for People's Forum was "Women, Land, Livelihood & People's Struggles." Representatives from different People's Struggles all over India involved in issues like land, Women and Livelihood made their presentations and shared their involvement mentioning milestones they have set through their work. Mr. Jeetendra Singh mentioned the need of Child Labour issue to be incorporated in debate and discussion under the theme, the suggestion was welcomed by all. Future direction was discussed and a joint approach towards the issues was decided.

Rev. Dr. Rodger Gaikward, General Secretary, NCCI was chief guest and the program was led by Mr. George Daniel, General Secretary, URM.

India was divided into 5 Zones; Mr. Jeetendra Sing was given the responsibility of Central India Zone to revive membership of organizations involved and carry on membership drive for new member organizations. A plan outline along with budget was asked to all Zone in-charges.



 **December 2013: -**

- a. **Staff Orientation** was done on 12th December 2013 at Bagbahara. New Staff were oriented about all the programs & activities of SMILE SESVS by Mr. Jeetendra Singh.

Mr. Abhilash Philip, Area Manager, Yuva Parivartan was also invited to share about Camps which are done in 25 different trades for financial sustainability.

Provision regarding Salary, Honorarium and Incentive was shared with all staff and new staffs were given offer letters.

Mr.Satish, Area Manager, ESAF was invited to share about National Pension System (NPS).

c. **T. B. Patient's Charter** Sensitization of 80 TB Patients on Rights & Responsibilities was organized at DMC Komakhan on 11th December 2013 by EHA.

Mr. Sanjeeb Barik led the meeting and introduced Mr. Jeetendra Singh and Mr. Shrivastav the resource persons.

Mr. Thakur, LT, Komakhan told the purpose of the meeting.

Mr. Jeetendra Singh shared the followings 8 Patient's Rights: -

- d. **DTO Meeting at DMC, Mahasamund** on 14th December 2013 a meeting of RNTCP Staff with NGOs was organized by RNTCP. During this meeting Mr. Jeetendra Singh shared the activities done by SMILE SESVS along marking on map. Mrs. Nibha Singh shared the problems and suggested the possible solutions. All the RNTCP staff presented their monthly activity report. Dr. Mandape, DTO encouraged all to follow the planning and achieve the set target.



- e. **Camp Awareness** for SHG members was organized on 26th December 2013 at Pandripani. Mr. Chandrabhan Mannade from Yuva Parivartan was invited to share about Camp and 25 different trades in which training is provided for financial independence. SHG members were very much encouraged and decided to get training in tailoring.

Mrs. Nibha Singh shared the activities of SMILE SESVS with present people and encouraged all to take the benefit under SMILE SESVS's SMILE Economy Development Program (SEDP).



✚ January 2014:-

- a. **UNION Meeting & Field Visit** on 8th January 2014 Mr. Gayadhar Malik, Consultant-UNION called a meeting of Project AXSHYA partnering NGO at Mahasamund. Mrs. Nibha Singh and Mr. Jeetendra Singh represented SMILE SESVS. Treatment adherence was discussed and activities till date were shared along with mapping which was appreciated by Mr. Malik and Field Visit to Junwani and Paterapali where on-going AXSHYA Samvad and meeting with patient were organized by SMILE SESVS. Mr. Gayadhar Malik interacted with villagers in general and with patients particularly and also saw wall paintings of Mid Media Activity.



- b. **One Billion Rising (OBR)** meeting was organized on 18th January 2014 at Anupam Nagar, Raipur for program planning of OBR, Mrs. Nibha Singh and Mr. Jeetendra Singh participated along with other organizations. Mr. Dongre was very much pleased to see the SMILE Economic Development Program (SEDP). SHG members presented pouches of Surya Washing Powder to Mr. Dongre and Mr. Dewangan. Mr. Dongre emphasized on developing market for washing powder and suggested free sample distribution of Surya Washing Powder in BSUP, Saddu to generate market. He also assured all the help in future.



d. SHG Orientation on NPS – On 21st January 2014, Mr. Jeetendra Singh conducted an orientation of SMILE Priya SHG on National Pension System (NPS).

SMILE SESVS has been appointed as Sub Aggregator by ESAF for NPS in Chhattisgarh.

Mr. Jeetendra Singh oriented SHG members regarding the benefits and provisions of PFRDA under SWAVALAMBAN – NPS.

SHG members were very much eager and asked questions regarding NPS and their contribution to get enrolled in NPS.

Mrs. Nibha Singh shared about the provision made by SMILE SESVS of Annual Beneficiary Membership (ABM) which provided the opportunity to get benefit under other programs of SMILE SESVS.

Mr. Jeetendra Singh Shared about the contribution of Central and State government along with their terms and conditions.

SHG members were encouraged to get them enrolled and also to propagate the scheme to others including their families.

SHG members were given an opportunity to serve as NPS Animator and get incentive on each enrolment.

Dr. Sangeeta Thakur, State Livelihood Specialist, Raipur Nagar Nigam assured to give an opportunity by introducing SMILE SESVS to other BSUPs in and around Raipur to enrol people in SWAVALAMBAN-NPS.



- e. **Dental Camp** was organized on 23rd January 2014 at BSUP, Dr. Kunhappan, Dental College; Raipur gave his service for this dental camp. Mrs. Prabha Singh, President-SMILE SESVS and Dr. Sangeeta Thakur, State Livelihood Specialist, Raipur Nagar Nigam were also present during Dental Camp. 87 children, women and men having tooth problem got themselves examined, treated and referred. Mrs. Nibha Singh led this Dental Camp and guided patients. Mr. Rajesh Kripal was responsible for registration. Memento was given to Dr. Kunhappan by Mrs. Prabha Singh.



- f. **Marketing Strategy-** Free distribution of Surya Washing Powder was done on 23rd January 2014 to ladies of BSUP. Saddu. Free distribution was done as a strategy to create market for Surya Washing Powder. 250gms packs were made and distributed and the message was shared to all that SMILE Priya SHG is into the production of washing powder, whole sale and retail can be purchased.



- g. **Presidential Visit to SEDP & SCDC at BSUP Saddu** – Mrs. Prabha Singh, President, SMILE SESVS visited SMILE Economy Development Program and SMILE CHILD Development Centre at BSUP Saddu on 23rd January 2014. 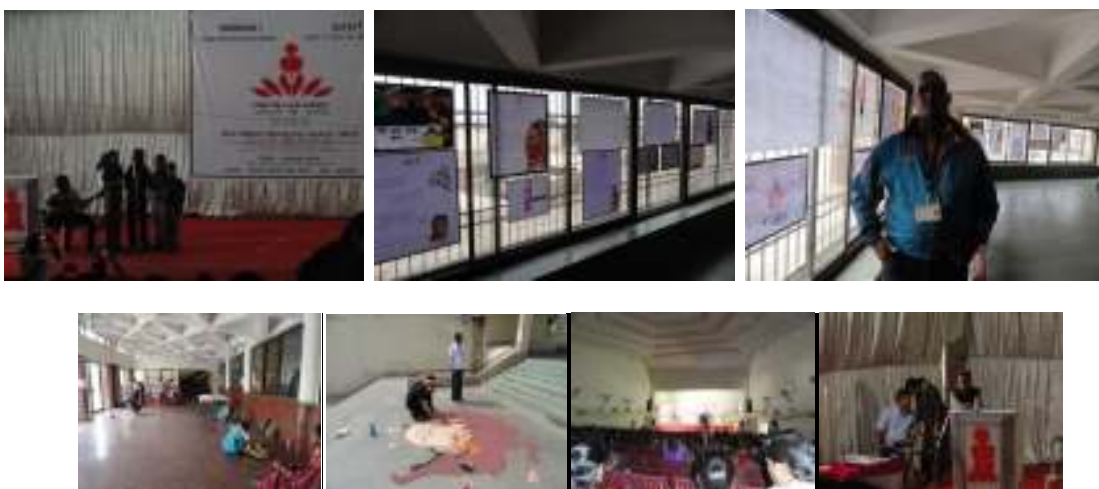


 **February 2014:-**
